Orders were made under section 24(6) of the Land Drainage Act 1930 and under section 68 of the Land Drainage Act 1976 (now section 38 of the Land Drainage Act 1991) dividing six of the former Drainage Districts (Smallburgh, Repps, Martham & Thurne, Happisburgh to Winterton, Muckfleet & South Flegg, Lower Yare First and Middle Bure) into Sub-Districts for the purposes of raising expenses. These orders were revoked in 2008. A copy of the Revocation Order is set out in this Part of the Register.

LAND DRAINAGE ACT 1991

BROADS (2006) INTERNAL DRAINAGE BOARD (DIFFERENTIAL RATING) (REVOCATION)
ORDER 2008

WHEREAS the Broads (2006) Internal Drainage Board as the drainage board for the Broads (2006) Internal drainage district are empowered by section 38(1)(a) of the Land Drainage Act 1991, for the purposes of levying differential drainage rates or issuing differential special levies, from time to time by Order to divide that district into sub-districts;

NOW THEREFORE the said Board, in exercise of the powers vested in them by section 38(1)(a) of the Land Drainage Act 1991, and after consultation with the Environment Agency (Eastern Region) hereby Order as follows:-

(1) This Order may be cited as the Broads (2006) Internal Drainage Board (Differential Rating) (Revocation) Order 2008 and shall have effect in relation to any drainage rate made and the issue of any special levy by the Board for any period commencing after 18 April 2008.

(2) The following Differential Rating/Exemption from Rating Orders are hereby revoked except in so far as they relate to any drainage rates made or special levies issued for a period ending before 17 April 2008:

Smallburgh IDB (Differential Rating) (Variation) Order 1973

Repps, Martham & Thurne IDB (Differential and Exemption from Rating) Order 1979

Happisburgh to Winterton IDB (Differential Rating) Order 1978

Muckfleet & South Flegg IDB (Differential Rating) Order 2000


Lower Yare First IDB (Differential Rating) Order 1963

Middle Bure IDB (Differential Rating) Order 1967
