Why this project matters

Our coastline is changing rapidly and the 70-year-old Benacre Pumping Station can no longer protect us.

Without urgent action, tidal and river flooding could:

- Threaten 35 homes and 46 businesses
- Flood 600 hectares of farmland
- Disrupt the A12, potentially closing it on every high tide

This isn't just about erosion, it's about protecting our communities, economy, and environment.

Our solution

We're building a resilient, long-term flood risk management scheme that includes:

- Two new embankments to defend against tidal flooding
- Two modern pumping stations using Archimedes screw pumps
- Creating 82 hectares of intertidal habitat, supporting wildlife and acting as a carbon sink
- Safe public access maintained throughout construction

A boost for biodiversity

The project includes a new intertidal habitat, with:

- Saltmarshes to support birds, fish, and invertebrates
- Carefully designed islands and landforms to support migratory and breeding birds
- Landscape features that blend with the surroundings and provide high-tide roosting areas

What's happening on site?

Our contractor, Balfour Beatty, started enabling works in March 2025, including:

- Setting up the construction site
- Vegetation clearance and wildlife protection
- Installing footpath diversions and river crossings
- Placing clear signage and public information boards

In Autumn 2025, we begin constructing haul routes and embankments

Planning & local impact

Clay will be sourced from Gisleham Quarry, with transport routes carefully managed via a one-way system and speed restrictions.

A one way system is in place around Benacre; on The Street, Back Lane and Locks Lane, Wrentham.

In Autumn 2025, we begin importing clay to build the new flood embankments. Consequently, a variation to the current planning permission for the extraction site has been submitted, and the consultation process is now open.
