#### EAST SUFFOLK INTERNAL DRAINAGE BOARD ORDER 2023

Notice is hereby given that the Secretary of State for Environment, Food and Rural Affairs in exercise of the powers conferred upon her by section 3(5) and (7) of the Land Drainage Act 1991, has now confirmed the East Suffolk Internal Drainage Board Order made on 24 March 2023 (S.I 2023 No. 364) confirming the Scheme submitted by the Environment Agency under section 3(1) of the Act.

The scheme makes provision for:

- i) the reconstitution of the East Suffolk Internal Drainage Board to reduce the number of elected members of the board from 11 to 10
- ii) to change the name of the board to the East Suffolk Water Management Board
- iii) matters supplemental to or consequential on that reconstitution

By paragraph 7 of Schedule 3 to the Land Drainage Act 1991, it is provided that if any person aggrieved by an order desires to question its validity on the grounds that it is not within the powers of the Act or that any requirement of the Act has not been complied with they may, within 6 weeks after the publication of this notice, make an application for the purpose to the High Court, and if any such application is duly made, the Court, if satisfied that the Order is not within the powers of the Act, or that the interests of the applicant have been substantially prejudiced by any requirements of the Act not having been complied with, may quash the Order either generally or in so far as it affects the applicants.
