- 1) The Tidal Deben is assessing 3 pumping station replacements & refurbishments. The Study is planned to commence in 2025/26. We will only be able to progress the project post OBC when a full funding package is in place.
- 2) The Alde & Ore Estuary WLMI is assessing 3 pumping station replacements & refurbishments. Work will start on the Outline Business Case (OBC) in 2023/24. We will only be able to progress the project post OBC when a full funding package is in place.
- 3) The Tidal Blyth is assessing 1 pumping station replacement or refurbishment. We will only be able to progress the project post OBC when a full funding package is in place.
- 4) The Upper Alde & Ore will strengthen & raise tidal embankments in the upper estuary. The project received full approval in January 2023 and detail design is expected to be complete in February 2024.
- 5) Lower Alde & Ore will strengthen & raise tidal embankments in the lower estuary. Work will start on the OBC in 2024/25 as we await confirmation regarding additional funding from Environmental Support Allowance. We will only be able to progress the project post OBC when a full funding package is in place.
- 6) The Public works loan of £772k in 2026/27 helped close the funding gap on Upper Alde & Ore. The Public works loan of £2m in 2029/30 is to help close the funding gap on Lower Alde & Ore.
- 7) The Alde and Ore Estuary Trust has previously funded the OBC for Upper Alde & Ore. There is £151k allocated to the OBC work on the Lower Estuary project and £600k forecast in 2026/27 towards the Lower Alde & Ore to help close the funding gap.
