

THE RIVER NENE CATCHMENT BOARD.

The River Nene Catchment Board (hereinafter called "the Catchment Board") in pursuance of Sub-Section (1)(b) of Section 4 of the Land Drainage Act 1930 have prepared the following Scheme making provision for certain matters mentioned in the said Sub-Section namely:—

1. The reconstitution of the Waldersey Drainage District and the Drainage Authority of the said District.
2. The amendment of the method of constituting the Commissioners for the Waldersey Drainage District so far as is necessary to secure that the Members thereof shall be persons elected as such Members in accordance with the provisions in that behalf contained in Part V of the Land Drainage Act 1930.
3. The making of alterations in the provisions of a certain Local Act which are expedient for enabling the area for the benefit of which drainage works are authorised thereby to be drained effectually.
4. Matters supplemental to and consequential thereon. And the Catchment Board submit the Scheme to the Minister of Agriculture and Fisheries for confirmation under Section 4 of the said Act.

SCHEME

As from a day (hereinafter referred to as "the Appointed Day") to be appointed by the Minister of Agriculture and Fisheries (hereinafter called "the Minister") the following provisions shall have effect:—

1. The District formerly under the jurisdiction of the Commissioners for the Waldersey Drainage District shall be known as the Waldersey Internal Drainage District.
2. The Commissioners for the Waldersey Drainage District acting under and by virtue of the Local Act 9 Geo. IV. cap. lxxxix shall be abolished.
3. The Drainage Board for the said Drainage District (which shall be known as the Waldersey Internal Drainage Board) shall consist of twelve members who with the exception of the first members shall be elected in accordance with the provisions in that behalf contained in Section 33 of and the Third Schedule to the Land Drainage Act 1930. The first Members shall be appointed by the Minister and shall hold office until the first day of November in the year next following the year in which the Order in relation to this Scheme comes into force.
4. The words "Waldersey Internal Drainage District" and "Waldersey Internal Drainage Board" shall be substituted in the Local Act 9 Geo. IV. cap. lxxxix for all references to the Waldersey Drainage District and the Waldersey Drainage Commissioners respectively.
5. Any provisions of the aforesaid Local Act relating to matters provided for in Section 33 of and the Third Schedule to the Land Drainage Act 1930 shall not apply to the Waldersey Internal Drainage Board.
6. All property rights powers duties obligations and liabilities vested in or to be discharged by the said Commissioners shall be transferred to and shall be vested in or discharged by the Waldersey Internal Drainage Board.
7. As respects any matter transferred under this Scheme the Scheme shall operate as conclusive evidence of the transfer without the necessity of any further assignment or deed of transfer.

Drainage Commissioners together with any penalties incurred in respect thereof may be recovered by the Internal Drainage Board in the same manner as if they had been rates levied by the Internal Drainage Board or penalties incurred in respect thereof.
